U.S. Air Force: Clinical Psychologist (Neuropsychologist) (O-4 billet, Supervisory) – Wright-Patterson AFB, OH

Job Description:

Licensed neuropsychologist who provides evidence-based psychologist assessment, treatment, and consultation for military beneficiaries. Conducts diagnostic interviewing, behavioral assessment, psychological testing, and neuropsychological evaluations in the diagnosis and treatment of psychiatric and neurological disorders. Provides military-specific mental health evaluations, to include medical evaluation board summaries (MEBs), fitness for duty evaluations, security clearance evaluations, deployment clearance evaluations, Military Training Instructor/Leader (MTI/MTL) evaluations, and Commander-Directed Evaluations (CDEs). Provides neuropsychological consultations to commanders, medical personnel, and legal authorities, as needed. Rotates in day and night call responsibilities (2 to 3 times per month) for emergent Mental Health cases and Family Advocacy Program consultation. Provides training and clinical supervision to psychology interns, psychiatry residents, social work residents, psychiatric nurse practitioner interns, and mental health technicians, as needed. Develops and implements psychology training curriculum for psychology internship program. Conducts individual supervision of psychology interns and conducts psychoeducational didactics for training programs. Supervises mental health trainees in on-call mental health emergency services in the mental health clinic and emergency department. Maintains accurate and current documentation in accordance with Air Force and local regulations. Participates in meetings and other appropriate professional activities.

Maintains all basic readiness standards as required by the U.S. Public Health Service. There are on-call responsibilities in this position. At least 51% of the incumbent's time will be spent on direct mental health patient care and/or mental health clinical management.

PHS officers assigned under this Memorandum of Agreement (MOA) must remain available for PHS deployments. Under this MOA, PHS officers are not authorized to deploy with the military.

Requires a SECRET clearance.

Initial assignment term is a 3-year obligation, with the option to extend for 1 or 3 years beyond the initial tour.

Requirements:

License: A current, unrestricted, and valid license as a doctoral-level clinical psychologist from a U.S. State (as defined in 42 USC 201 (f)) is required.

Training: The candidate must possess a qualifying doctoral degree in clinical or counseling psychology from an American Psychological Association accredited university or professional psychology program and completed an APA accredited internship in clinical psychology.

Additional Requirements:

Post-doctoral specialization in neuropsychology is required.

Preferences:

Prefer a minimum of 3 years of clinical experience.
