

Job Title:

Joint Task Force CAPMED: Staff Psychiatrist, Child Psychiatry Clinic (O-5, Non-Supervisory) – Walter Reed National Military Medical Center, MD

Job Description:

Psychiatrist sees 6-8 patients per day in an outpatient clinic and occasional inpatient consultations on inpatient pediatric unit; individual and group counseling services also offered in this clinic.

Duties include providing direct assessment, diagnosis, and treatment (to include medication management) to child and adolescent beneficiaries of uniformed service members. May also be required to see adult patients. Provides consultations with primary care managers, families, and schools as needed. Clinician will participate in multidisciplinary clinical case staffing. May be required to conduct command-directed mental health evaluations and evaluations for security clearances. Manages suicidal/homicidal patients, to include the arrangement of hospitalizations, as appropriate. Supervises, mentors, and trains unlicensed providers and technicians staff, as appropriate. May provide clinical supervision for residents and interns. Participates on and/or directs military-specific trainings, such as disaster response. Other duties as assigned. At least 51% of the incumbent's time will be spent on direct mental health patient care and/or mental health clinical management.

Maintains all basic readiness standards as required by the U.S. Public Health Service.

Experience with military populations is preferred.

Requires a Secret clearance.

Requirements:

License: A current, unrestricted, and valid medical license from a U.S. State (as defined in 42 USC 201 (f)) is required for an appointment to the Corps.

Training: A candidate must possess a qualifying Doctor of Medicine (M.D.) or Doctor of Osteopathic Medicine (D.O.) degree from a medical school accredited by the Council on Medical Education of the American Medical Association or

Bureau of Professional Education, Committee on Colleges of the American Osteopathic Association, respectively. Must be Board Certified in General Psychiatry, BE in Child and Adolescent Psychiatry.

Additional Requirements:

This job requires on-call responsibilities. This job requires a minimum of a 3 year commitment.

PHS officers assigned under this Memorandum of Agreement (MOA) must remain available for PHS deployments. Under this MOA, PHS officers are not authorized to deploy with the military.
