Use knowledge, skills, and judgment in complex clinical and administrative functions with a variety of psychiatric patients and with a variety of disciplines, e.g., medicine, psychiatry, psychology, social work, occupational therapy, nursing and others. Care provided frequently includes the identification and definition of previously unknown conditions and resolving critical problems.

Evaluates health care needs of patients and develops plans to meet these needs. Devise, implement and evaluate plans of mental health care utilizing evidenced based clinical judgments of the physical, psychological, emotional, social and environmental needs of the clients. Conduct complete assessment of the problem with the authority to request treatment, such as request for laboratory work, special screenings, etc.

Ensure adherence to medical and nursing regimens to stabilize chronically ill persons; adjusts regimens within established protocols recognizing when to refer the patient to the physician or other health team members. Provide treatment consistent with clinical impressions and working diagnoses.

Screen new patients, perform initial biopsychosocial assessments, take histories, order diagnostic tests and laboratory studies and interpret data obtained from the results. Reviews result of evaluation to

distinguish between normal and abnormal findings to recognize early stages of serious physical, emotional or mental problems that must be addressed. Make decisions concerning the implementation of data, planning and refining methods in regards to patient's conditions and making alterations in treatment and diagnostic regimens.

Is comfortable being on call and responding to emergency room and hospital requests for consultation. Freely consults with psychiatrists on cases and participates in Department case conference. Advises Commands of unique military requirements regarding mental health and is able to put patients on Limited Duty and to complete Narrative Summary for Integrated Disability Evaluation System.

Maintains all basic readiness standards as required by the U.S. Public Health Service. PHS officers assigned under this Memorandum of Agreement (MOA) must remain available for PHS deployments. Under this MOA, PHS officers are not authorized to deploy with the military.
